

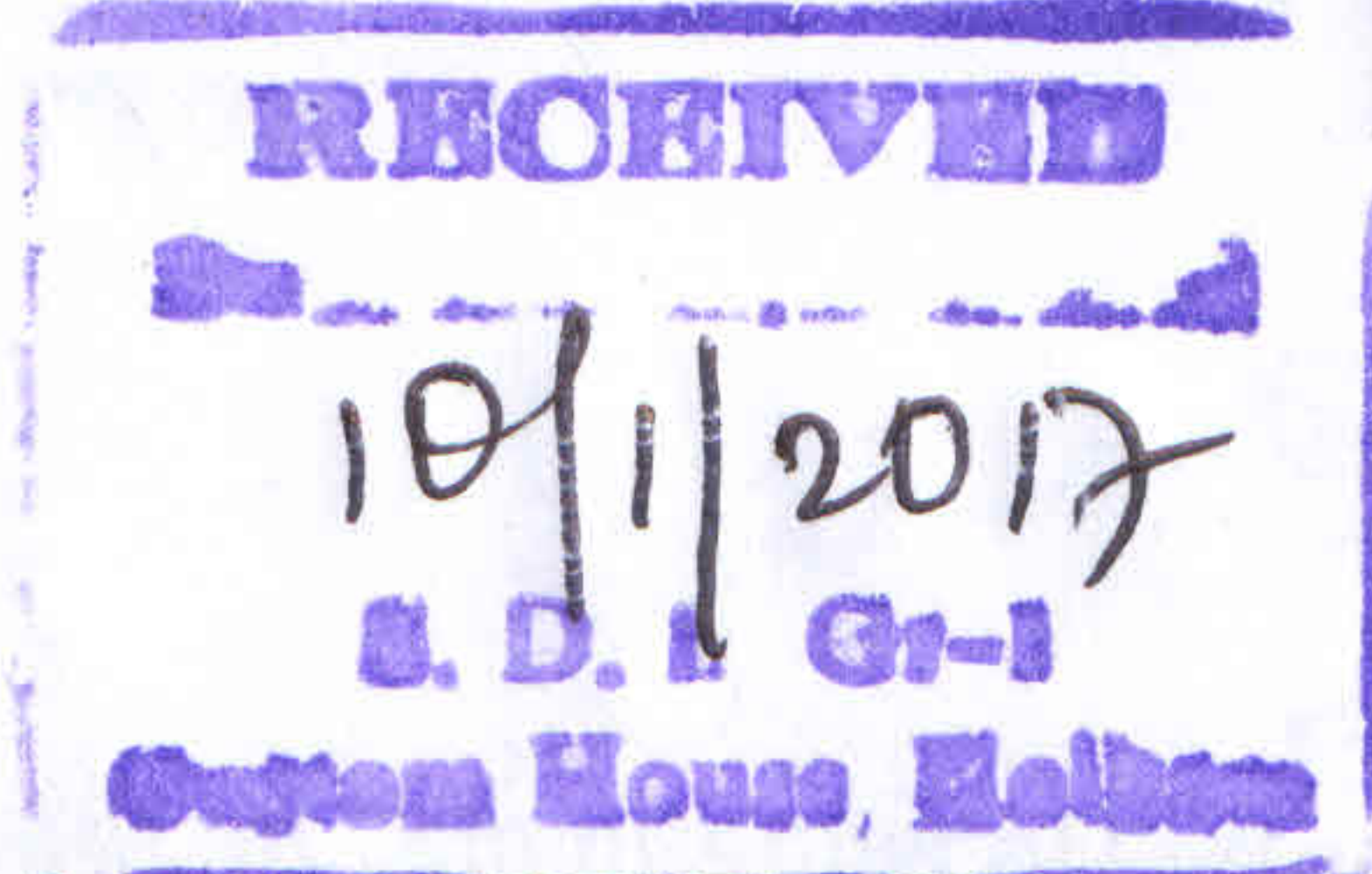



An Order-in-Original No. KOL/CUS/PORT/COMMR/30/2016 dated 29.03.2016 has also been issued in this regard.
2	If issued, kindly provide the copy of the show cause notice.	
3	Kindly inform whether the goods have been auctioned or the same are still in the custody of the customs.	Information sought by applicant in point (3) and (4) is not related to this unit.
4	If the same are in custody of the customs, kindly inform as to where the subject goods are stored at present.	

As per Right to information Act, 2005, photocopying charges of Rs.2/- per page is to be deposited.
