Subject: Amendment of Public Notice No. 29/2020 dated 15.04.2020 regarding "Measure to facilitate trade during the lockdown period - Section 143AA of the Customs Act, 1962".

Attention of the Importers, Exporters, Customs Brokers and all other stakeholders is invited to CBIC Circular No. 23/2020-Cus dated 11.05.2020 and Public Notice No. 29/2020 dated 15.04.2020 based on CBIC Circular No. 17/2020-Cus dated 03.04.2020 regarding "Measure to facilitate trade during the lockdown period - Section 143AA of the Customs Act, 1962".
