PUBLIC NOTICE NO - 30/2021

Sub: Measure to be taken to for speedy clearance of COVID related items-reg;

1. Attention of all Importers/Exporters, Custom Brokers, Custodians of Import Shed, General Trade, Air Lines, Partner Government Agencies (PGAs) and all other stakeholders is invited to above-mentioned subject.
2. It has been decided to maintain a daily updated status of all COVID related imports being cleared from Import Shed under the Airport Commissionerate. The record should contain nature of the goods whether they are in the form of Active Pharmaceutical Ingredient (API)/Key Starting Materials (KSM)/ Drug Intermediates (DI) of medicines/ vaccines /machines/parts etc. Further, Officers involved in the assessment and clearance of subject import consignment must ensure that goods relating to the Original Equipment Manufacturers (OEMs) and industrial purpose are cleared on a priority basis. The contact details of the Officers involved in clearance of the goods at Import Shed, ACC, NSCBI Airport, Kolkata are given in Annexure 'A'.
3. The Officers posted in FAGs are also advised to assess the above-mentioned goods on priority **basis** and keep a status of the pending Bills of Entry and the reason thereof on daily basis.
4. In view of the current situation, a special task force headed by

Nodal Officer at the level of ADC has been formed consisting of one Appraiser, one AC as detailed in Annexure 'B', for the clearance of "COVID related items" during odd hours & holidays. Trade may contact the mentioned officers in case of any difficulty, which they face, in clearance of COVID related items.
