

Also Adjudicating Authority granted you the personal hearing on 17.03.2022 to present his case, however you were not presented for personal hearing.

Accordingly, before adjudicating the above mentioned Show Cause cum Demand Notice, the adjudicating authority is accorded to grant you another opportunity of the Personal Hearing (PH) on dated 20.05.2022 at 02.30 PM in his office at Air Cargo Complex. In this connection, it is requested to attend the PH with all the documentary evidences in support of realization of foreign remittance in stipulated time allowed under FEMA Act, 1999 along with application of extension and approval of extension.
