Subject: Amendment of Public Notice No. - 01/CC/2017 dated 6.9.17

Attention of the trade, public and all concerned is invited to the Public Notice No. - 01/CC/2017 dated 6.9.17 regarding modification of the jurisdiction of the Commissionerate of Customs (Prev.) pursuant to issue of Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise & Customs, Notification No. 82 / 2017 - Customs (NT) dated 24th of August, 2017.

In partial amendment the third paragraph of Public Notice No. - 01/CC/2017 dated 6.9.17 may be read as,

"This notification effectively brings all the Customs formations under the erstwhile Commissionerate of Central Excise, Service Tax and Customs, Siliguri, within the jurisdiction of the Commissionerate of Customs (Preventive), West Bengal. The Customs formation in the UT of Andaman & Nicobar Islands shall continue to be within the jurisdiction of the Commissionerate of Customs (Port) as per existing arrangement till further orders."

All other contents of the Public Notice No. - 01/CC/2017 dated 6.9.17 remain unchanged. These Public Notices shall come into effect from the 1st of November, 2017 in pursuance of GOI. Ministry of Finance, Department of Revenue, Central Board of Excise & Customs, Notification No. 86 / 2017 - Customs (NT) dated 14.9.2017.
