Information pertaining to Kolkata Customs Commissionerate under CBIC as sought for is given below as per the available records:-

Para Nos.1 & 2- It is for information here that the New Pension Scheme has been implemented w.e.f. 01.01.2004. There is a considerable number of officers appointed in this Commissionerate w.e.f. 01.01.2004 to till date. Out of them to draw the list of officers appointed on or after 01.01.2004 but covered under old pension scheme is a difficult and time consuming job. However, it is for information that the Personnel and Establishment section is entrusted with the job of giving appointment and their salary is being drawn by the Accounts Department. The list can be drawn by the joint consultation by the Personnel and Establishment section and Accounts Department. It is not possible to provide such information within the stipulated time without hampering the regular office work. However, to maintain the spirit of the RTI this section will provide the desired information as soon as possible.

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. M. A. Ansari, Addl. Commissioner of Customs, 1st. Appellate Authority (A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.
