Minutes of the Customs Clearance Facilitation Committee Meeting (CCFC) held on 08.02.2018 at 03:00 p.m. in the Board Room of Custom House, Kolkata

The Customs Clearance Facilitation Committee Meeting was held in the Board Room of Custom House, Kolkata on 08.02.2018. The meeting was presided over by the Commissioner of Customs (Port), Kolkata.

Commissioner of Customs (Port) welcomed all the members to the meeting. All officers and invitees introduced themselves.

Following points were discussed in the meeting and decisions taken:

1. Representative of FSSAI informed that transmission of documents through SWIFT is still not regularised/ streamlined. It is noticed, in some cases it takes more than 20 days. Problem of non transmission of documents was examined and discussed in detail by members present in the meeting.

Response/Decision

The matter has already been taken up with DG (Systems). SWIFT team of DG, Systems is working on resolving the problem.

2. Representative of CCHAA informed that delay occurs in export shipment due to drawl of samples in late hours and insistence of original documents by P.Q authority. It is proposed to start drawal of sample with the copy of original document.

Response/Decision

Deputy Director, RPQS, Kolkata explained that P.Q formalities cannot begin without original document as there is no such legal provision. Constraint of lack of adequate officers is also pointed out. It is clarified that time of clearance by P.Q Authority cannot be reduced as desired by CCHAA, as it depends upon the chemical properties of chemical used in fumigation which has been elaborated in NSPM Rule 22 & 12. In this context of clarification given by Dy. Director, RPQS Commissioner of Customs advised that a P.N/Advisory be issued clarifying said Rule by P.Q Authority.

3. A.C, NSD also pointed out that field provided for N.O.C from P.Q, it is reflected as 1 in place of N.O.C, which may be clarified.

Response/Decision

It is replied by Dy. Director, RPQS that it is System/Server related problem. Commissioner of Customs (Port) requested that RPQS send its reply on this issue in response to a letter sent by Joint Commissioner of Customs (Port) dated 06.02.2018.

4. Representative of CCHAA said that officers working in CFS should be provided with VPN Ids.

Response/Decision

CFS's have already been provided with VPN Ids' for officers. Remaining CFS's will also be covered.

5. Representative of Textile Committee informed that Test Fees have been revised as Rs.2000.00 and Rs.2500.00. It is also requested to forward contact details of CB/Importers for recovery test fees & handing over test report.

Response/Decision

Contact details as available would be forwarded to Textile Committee.

This issues with the approval of the Commissioner of Customs (Port).


