Subject: Setting up of IGST Refund Cell

Attention of the trade, public and all concerned is invited to the setting up of IGST Refund Cells in all the three Commissionerates in this zone in order to alleviate the difficulties being faced by the exporters in getting their due refunds due to various factors.

The sections concerned have been directed to inform the exporters about the specific irregularities and shortcomings which have led to the stalling of the refunds by the system. The exporters are requested to respond immediately to the queries and correspondences so that appropriate action can be taken.

These officers may be contacted in case of non receipt of IGST Refunds. Further, the Additional Commissioner / Joint Commissioner of the Commissionerates may be contacted in case of unresolved issues.
