PUBLIC NOTICE NO. 21/2018

**Sub: Procedure for movement of containerized import cargo form Port Terminal to different Container Freight Stations (CFSs) under Kolkata (Port) - Implementation of CFS Gate Module under ICES Version 1.5.**

Attention of all Steamer Agents/Shipping Lines, Main Line Operators (MLO), Importers, Customs Brokers, CFS operators, Kolkata Port Trust and Stake Holders is drawn to Public Notice Nos. 07/2018 dated 23/01/2018 and 09/2018 dated 14/02/2018 on the subject matter.

It has come to the notice that even after extending implementation date till 01/03/2018 vide Public Notice No. 09/2018 dated 14/02/2018 to allow MLOs to register one time Authorizations, most of the MLOs have failed to do so. As a result Customs could not implement the CFS GATE Module w.e.f 01/03/2018. Therefore, the implementation of the CFS Gate Module has been further postponed to 18/03/2018. MLOs are expected to complete the registration of one time Authorization by 17/03/2018 as no further extension shall be given after 18/03/2018.

Further, as intimated vide Public Notice No. 09/2018 dated 14/02/2018, there is no option to generate Gate Pass at the time of movement of trucks from Terminal to CFSs. However, in partial modification of +said Public Notice, instead of Form-II Preventive Officer(s) shall endorse the Truck No., Container No., Seal No., Gate Pass No. date and time, on the copy of the Cargo Movement Approval Order.
