**Parawise information pertaining to Kolkata Customs Commissionerate under CBIC as sought for is given below as per the available records:-**

**Para no. 1:-** In this context it is pertinent to mention that the instruction contained in Para 4 of CBIC's letter issued under F. No. A. 12034/SSC/04/2016-AdIII (B) dated 22.06.2018 it is mandatory to verify the character and antecedents of the candidates (Police Verification Report) before issuing appointment letter. However, in terms of the Board's instruction vide its letter dated 04.08.2016 under F. No. C-30013/8/2016-Ad. IV-A enclosing Dop&T OM No. 18011/2(s)/2016-Estt.(B)(i) dated 29.06.2016 the Chief Commissioner of Customs has been pleased to approve issuance of offer of Appointment to the candidates nominated for appointment as Tax Assistant vide CGLE- 2016 pending PVR with a rider as reproduced below:-

"Your appointment is purely provisional and subject to the verification of character & antecedents, verification of original certificates regarding date of birth, educational qualification, caste certificate, disability certificate and medical examination report etc and if verification report reveals that the certificates and other particulars submitted by you are false, your candidature for the post of Tax Assistant will be terminated without assigning any reason or notice and without prejudice to such further action as may be taken under the provisions the Indian Panel Code for production of false Certificates/Information."

**Para no. 2 & 3:-** Already explained in Para 1 above.

If you are aggrieved with the above information, you may prefer an appeal against the same to Shri. Amrendra Narayan, Addl. Commissioner of Customs, 1<sup>st</sup>. Appellate Authority ( A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.


