**PUBLIC NOTICE No. 63/2018**

**Subject:** Removal of Nepal bound containers transiting by rail after detention free period at N.S. Dock.

Attention of the Nepal importers, Custom House Brokers, Steamer Agents and all others concerned is brought to the removal of Nepal bound containers transiting by rail after detention free period at N. S. Docks to various CFSs. These containers are subsequently moved under Customs Preventive escort for loading on the Rail rakes at CTKR Rail Terminal of CONCOR at Majerhat, Kolkata resulting in additional handling and transportation cost.

2. Representation has been received from Nepal Trade and Customs Brokers on behalf of Nepal importers that all such containers be moved only to CONCOR – CFS at Majerhat, Kolkata instead of any other CFS in order to reduce additional transportation and handling charges on such movement.
3. Considering the representation and as a measure of trade facilitation, it has been decided that after detention free period at N.S. Docks, if no specific request has been submitted by the importer / his Customs Broker/Shipping Line to Kolkata Port, such Nepal bound containers transiting by Rail shall be moved only to CONCOR – CFS at Majerhat, Kolkata and not to any other CFS.
4. Customs Preventive Officers posted at CONCOR – CFS at Majerhat, Kolkata shall supervise loading of containers at CTKR Rail Terminal of CONCOR at Majerhat, Kolkata and make necessary endorsements on the CTD. CONCOR – CFS will provide dedicated space in their CFS for storage and handling of such Nepal Transit Containers.
5. Any difficulties arising in implementing this Public Notice may be brought to the notice of the undersigned.
