Parawise information pertaining to Kolkata Customs Commissionerate under CBEC as sought for is given below as per the available records:-

- Para no. 1.:-** a) Between 25.04.1989 to 01.07.1997, reservation was not given to promotee Cadres as prescribed in the O.M. No. 36012/17/88-Estt.(SCT), dated 25.04.1989. From 02.07.1997 to till date, reservation of SC/ST employees was as per with the roster point earmarked for the respective category as per DoPT O.M. No. 36012/2/96-Estt (Res), dated 02.07.1997.
- b) As per DoPT O.M. No. 36012/2/96-Estt (Res), dated 02.07.1997, all vacancies were assigned to post based. As such, reservation for SC/ST employees were as per the roster point earmarked for the respective category.
- c) No promotion is given effect as per the provision of R.R. vide GSR 1172(E), dt. 26.12.2016.

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Addl. Commissioner of Customs, 1st. Appellate Authority (A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.
