**Subject: -Providing information under R.T.I. Act, 2005 – regarding**

Please refer to your RTI application dated nil, seeking information under the provision of right to Information Act, 2005. On scrutiny of your application along with 02 nos. Indian Postal Order 1) bearing No. 23F 138316 of Rs. 10/- as RTI fees and 2) bearing no. 73G 942962 of Rs. 50/- addition charge for providing related documents has been issued in favour of The "RBI, A/C. Commissioner of Customs, Kolkata" received on 15.05.2018 and same has realised by Cash Section, Custom House, Kolkata.

**Parawise information pertaining to Kolkata Customs Commissionerate under CBEC as sought for is given as below as per the available records :-**

**Para no. 1 :** The file bearing No. S 51-67/87 Estt (pt. I) regarding Promotion to LDC against 10% quota from L.As, R.Cs and Sepoy/Havalders which strats from 06.02.1998 and end on 22.07.2003 has thoroughly been studied. The facts and notes in respect of the DPC in question i.e. the DPC which was held 09.12.1999 corresponding to Estt. Order 368/99 dated 22.12.1999 for ad-hoc promotion to the post of LDC has been found intact in the file though the Self Contained Notes and Minutes of the DPC, which has requested to provide under RTI Act,2005 is not found in the file. Accordingly, the ' Self Contained Notes and Minutes of the DPC ' which was held on 09.12.1999 corresponding to Estt. Order 368/99 dated 22.12.1999 for ad-hoc promotion to the post of LDC, could not be provided presently.

**Para no. 2 :** The file bearing No. S 51-67/87 Estt (pt. I) regarding Promotion to LDC against 10% quota from L.As, R.Cs and Sepoy/Havalders which strats from 06.02.1998 and end on 22.07.2003 has thoroughly been studied. The facts and notes in respect of the DPC in question i.e. the DPC which was held 22.07.2003 corresponding to Estt. Order 224/ 2003dated 22.07.2003 for confirmation of 11(eleven) ad-hoc LDC to the post of regular LDC, has been found intact in the file though the 'Self Contained Notes' and 'Minutes' of the DPC, which has requested to provide under RTI Act,2005 is not found in the file. Accordingly, the ' Self Contained Notes and Minutes of the DPC 'which was held on 22.07. 2003 corresponding to Estt. Order 224/2003 dated 22.07.2003 for confirmation of 11 (eleven) ad-hoc LDC to the post of regular LDC, could not be provided presently.

**Para no. 3 :** On thorough study of the facts and notes in respect of the DPC in question i.e. the DPC which was held on 22.07.2003 corresponding to Estt. Order 224/2003 dated 22.07.2003 for Confirmation of 11 (eleven) ad-hoc LDC to the post of regular LDC it has been observed that the Officers as listed in Establishment Order No. 224/2003 dated 22.07.2003 have been promoted on Seniority-Cum Fitness basis in 5% quota. Smt. Sukla Roy at Sl. No. 04 (four) has appeared for Departmental Examination for promotion to the post of LDC but could not pass. Attendance Sheet and Result in this regard has been found, though the same in respect of other Officers as listed in Establishment Order No. 224/2003 dated 22.07.2003 do not exist. Hence could not be provided..

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Addl. Commissioner of Customs, 1<sup>st</sup>. Appellate Authority ( A & A),Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata-700 001 within 30 (thirty) days from the date of receipt of this letter.


