Para no1. Desired information as sought by you in your RTI application against para no. 1 is as below:-

All documents were thoroughly searched and matched; and as per the available records, no such seniority list as on 01.01.1985 in the cadre of P.O. & E.O. was available in this Office. However, the best possible seniority lists available with regard to the requested date are -

1. Seniority list of P.O as on **26.12.1983** vide Estt. Circular no. **267/83** (09 pages).
2. Seniority list of E.O. as on **01.06.1986** vide Estt Circular no. **207/86** (06 pages).

In view of the above, there are 15 pages in total and if you wish to collect the above mentioned documents, hard copies of the same may be obtained after payment of requisite fees at Rs. 2/- per page as per sub section (4) of Section 4 and sub-sections (1) and (5) of Section 7 of RTI Act 2005. The receipt of the payment made may be sent to the undersigned and then the requisite documents will be dispatched to your address within 10 (ten) days from the receipt of the same.

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Joint Commissioner of Customs, 1st. Appellate Authority (A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.
