**Parawise information pertaining to Kolkata Customs Commissionerate under CBEC as sought for is given as below as per the available records:-**

**Para no. 3. :** Nobody on behalf of Kolkata Customs Zone attended the meeting held on 18.09.2017 as per available record. So question of Transfer Allowance/ Accomodation claim does not arise.

**Para no. 2 :** Inter Commissionerte Transfer is allowed as per the instructions laid down in the CBEC order vide F. No. A- 22015/23/2011 Ad IIIA dated 27h October, 2011. The provision of Inter Commissionerte Transfer is not encompassed in the Recruitment Rules. So question of overlooking and ignoring the Recruitment Rules, 2016 notified vide G.S.R.1172(E) issued vide F. No. A 12018/30/2003 Ad. III.B dated 26.11.2016 does not arise .

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Joint Commissioner of Customs, 1<sup>st</sup>. Appellate Authority ( A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter
