Please refer to your RTI application received on 12.10.2017 from CPIO & Dy. Commissioner of Customs, R.T.I. Cell (Airport & Admn.), Custom House, Kolkata enclosing letter of Chief Commissioner Office, Custom House, Kolkata and Shri Virendra Arora, CPIO & Assistant Director, Govt. of India, Ministry of Finance, Deptt. of Revenue, CBEC, North Block, N. Delhi vide F no. 8/B/03/HRD(HRM)/2014/Pt. 1/ dated 25.09.2017 comprising of a RTI Application dt Nil.

Parawise information pertaining to Kolkata Customs Commissionerate under CBEC as sought for is given as below as per the available records:-

Para Nos. 3 (iv) & (vi) :- The questions at Sl. Nos 3 (iv) & (vi) speaks of Rules/Instruction/ Guideline followed in determining the relative seniority of the direct Examiners and promotee Appraisers (for direct recruit Examiners) who were recruited through the same All India Competitive Examination 1990.

As per the available records with this Office, no such seniority list for the mentioned period ^{could} can be found. Hence, the question of applicability of Rules/Instruction/Guideline does not arise. However, at present a Committee has been formed to review and refix the seniority of all cadres to incorporate the direction passed by the Hon'ble Supreme Court in Civil Appeal No. 7514 – 7515 of 2005 in the case of N. R. Parmar & Others Vs. UOI & Others. The process is still in progress.

Para Nos. 3 (v) & (vii) :- As the questions pertains to different Commissionerates, the answer to these is not available with this Office.

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Joint Commissioner of Customs, 1st. Appellate Authority (A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.
