No. S51 (Misc.) – 96/2016 Estt. (Pt.) dated 30.01.2017 and its addendum issued on 23.03.2017 vide F.No. S38 – 03/2017 Estt. (Pt.) (Copy enclosed).

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Joint Commissioner of Customs, 1st. Appellate Authority (A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.
