If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Joint Commissioner of Customs, 1<sup>st</sup>. Appellate Authority ( A & A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.
