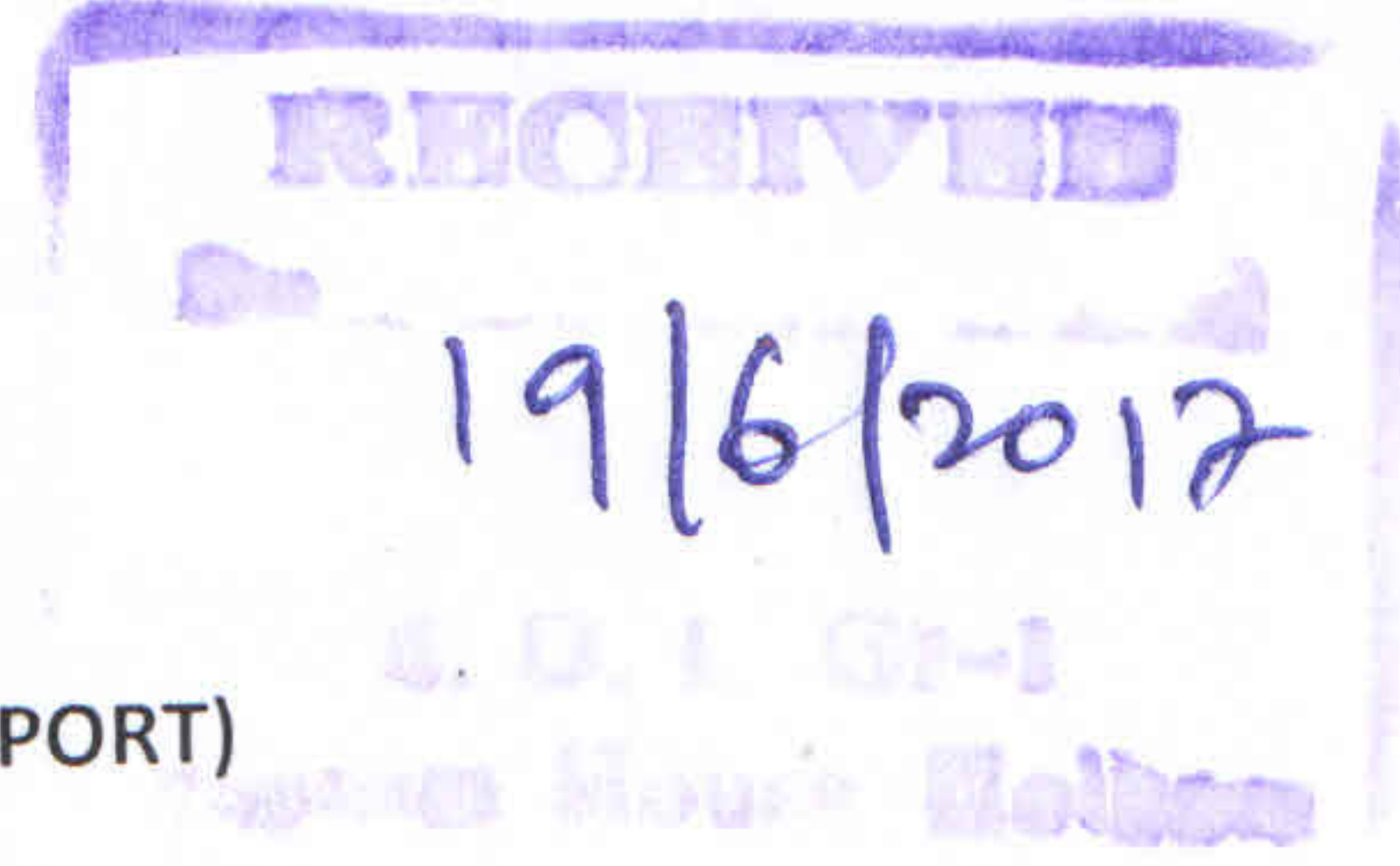

Subject: - Information sought by Shri Ashwini Kumar under RTI Act, 2005- reg.

Please refer to your RTI application vide Registration No. DGVAL/R/2017/50006, dated 23.05.2017, wherein you have sought the information regarding empanelment of Chartered Engineer.

The point-wise reply of your above mentioned RTI application with respect to the Kolkata Custom House is as below:

Point 1	<p>Eligibility: The applicant should be duly affiliated to & recognised by the Institute of Engineers.</p> <p>Process & procedure: Custom House issues a Public Notice for empanelment and applications are invited in the prescribed proforma from Chartered Engineers (Individual or Company) represented by the individuals of various branches of specialisation for empanelment. Names of applicants are shortlisted for interview and schedule of interview is published. Shortlisted candidates are called for an interview whereupon final selection is made. The empanelment is done through a process of formal interview by a panel of expertise. Then Custom House issues a Public Notice giving name & address of selected Chartered Engineers. On selection, selected Chartered Engineers need to submit a self appraisal to assess their performance to decide whether they are fit to continue. The selected panel is valid for a period of one year, which is reviewed thereafter.</p>
Point 2	<p>There is no Notice, Tender or Limited Tender has been issued from Kolkata Customs for the current financial year 2017-18 till date.</p>

If you are aggrieved by the decision of providing you the above information, you may refer an appeal under section 19(1) of the RTI act, 2005 within 30(Thirty) days of receipt of the information to Shri P.K. Bohra, Addl. Commissioner of Customs (First Appellate Authority), Custom House, 15/1, Strand Road, Kolkata-700001.
