Please refer to your RTI application dated 02.08.2017, which has been transferred under section 6(3) of RTI Act, 2005 by Shri Piyush Bhardwaj, Nodal Officer, Govt. of India, Ministry of Finance, Deptt. of Revenue, CBEC, N. Delhi vide F no. 402/02/2017-Cus.III (PT-III) dated 09.08.2017, CPIO & Assistant Commissioner of Customs, Chief Commissioner unit, CPIO & Asstt. Commissioner of Customs, R.T.I. Cell (Airport & Admn.), Custom House, Kolkata. The said RTI application was received on 28.08.2017 by this Deptt.

Para wise information pertaining to Kolkata Customs Commissionerate under CBEC as sought for is given as below as per the available records:-

Para no. 1 : No record of any seniority list of P.O's who joined Kolkata Customs between 01.01.03 to 27.11.12 was found published before 27.11.2012 in Kolkata Custom Commissionerate (A&A).

Para no. 2 : As per available records the latest seniority list of Inspectors published Inspectors who were recruited after 01.01.2003 was vide Estt. Circular No. 40/2013 dated 26.04.2013, then revised vide Circular No. 58/2014 dtd.10.03.14 after that it was again revised vide Circular no. 70/2014 dtd.07.07.14 in Kolkata Custom Commissionerate (A&A).

Para no.3 : As per available records, for the direct recruitment of Preventive Officers in Kolkata Customs, DGHRD, HRM wing is treated as reporting authority and SSC is treated as recruiting authority.

Para no. 4. : Since this office does not directly correspondences with CBEC, necessary corresponding to point no.04 of RTI application may be obtained from Chief Commissioner's Office. Hence, the Point no, 04 of the RTI application is hereby transferred to CPIO & AC/DC, C.C.O. Custom House, Kolkata, as per provision 6(3) of RTI Act,2005 for providing the information directly to the applicant with an intimation to the undersigned.

Para no. 5. : As per available records, there are 31 pages to notesheet in File No. S51-02/04 Estt .copies may be obtained after payment of fees as per sub section (4) of Section 4and sections (1) and (5) of Section 7 of RTI Act 2005.

Para no. 6. : As per available records in this Kolkata Customs Commissionerate under CBEC there are two transfer policy posting norms, one for Suprintendent & P.O. and another is Appraiser & Examiner. But in the both norms are not mentioned to posting of Suprintendent, P.O., and Appraiser & Examiner in the Establishment Section.

Para no. 7. : The desired information is not available in this Establishment Section of Kolkata Custom Commissionerate.

Para no. 8. : No records of seniority list of Inspectors of zones other than Kolkata Customs Zone is available in this office. Seniority Inspectors (PO) as on 31.07.2017 for Kolkata Customs Zone has not been finalised yet.

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri. Amrendra Narayan, Joint Commissioner of Customs, 1st. Appellate Authority (A&A), Office of the Commissioner of Customs, Custom House, 15/1, Strand Road, Kolkata- 700 001 within 30 (thirty) days from the date of receipt of this letter.
