Please refer to an Order-in –Appeal dated 31.10.2017 which has been received by this department on 03.11.2017 vide Order -in –Appeal No.-06/JC/KOL/CUS/RTI(Appeals)/2017(AP & Admn.) from Appellate Authority & Jt. Commissioner of Customs (A&A) under F. No. S(RTI-05)—11/2017(AP & Admn.)

Point-wise Information pertaining to Kolkata Customs Commissionerate under CBEC as sought for is given as below as per available records:-

Point No .1 –Further to the earlier reply dated 22.08.17, it is to mention that a letter has been issued to the Principal, Om Sai Nath , Sr. Sec. School, Khariya, Post- Nameni (Kasganj), U.P.-207124 on 06.09.2017, however, reply of the same is still awaited.

Point No.2- Further to the earlier reply dated 22.08.17, it is to mention that as per DOPT O.M. dated 05.05.2003, the case of compassionate appointments, which have completed 03(three) years, were closed. However, as per DOPT O.M. vide F.No. 14014/3/2011Estt.(D) dated 26.07.2012 read with CBEC letter F.No.A12012/39/2012 Ad III.B dated 04.10.2012, the case of compassionate appointments which have already been closed ,are taken into consideration again and thereafter compassionate appointment was made in the cadre of MTS and TA in 2014 where the minimum educational qualification was Matriculation or equivalent and Graduation from a recognized Board/University respectively. Your application was not considered as per DOPT guideline in the Screening Committee Meeting held on 03.12.2014. The date of conduct of next Screening Committee Meetings is yet to be fixed as the matter is under process.
