

Para no.3. : Sanctioned strength of Tax Assistant is 347 as on 01.05.2018. & total number of Working strength of Tax Assistant is 178 as on 01.05.2018 and total number of Sanctioned strength of Executive Assistant (erstwhile DOS + STA) is 248 as on 01.05.2018 & total number of working strength of Executive Assistant (erstwhile DOS + STA) is 155 as on 01.05.2018 .


