

Section (8)(1) (j) of RTI Act 2005- no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information.

On the above ground, this office may deny to disclose the information sought by you.


In case, you are not satisfied with the information provided, you may make an appeal to the appellate authority within 30 days from the date of receipt of this letter as per provision of section 19 of the RTI Act, 2005. The particulars of the appellate authority are as follows:-
