This office has no obligation to supply the information sought by you as per "information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the Appellate Authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information" under section 8(1)(j) of RTI ACT, 2005 and "There shall be no obligation to give any information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party unless the competent authority is satisfied the larger public interest warrants the disclosure of such information" under section 8 (1) (d) of RTI Act, 2005.
Hence the same are denied.

In case, you are not satisfied with the information provided, you may make an appeal to the appellate authority within 30 days from the date of receipt of this letter as per provision of section 19 of the RTI Act, 2005.
