Please refer to your RTI Application dated 04.01.2020 received from CPIO & Asst. Commissioner of Customs, R.T.I Cell(Airport & Admin), Custom House, Kolkata.

The reply of the information sought by you are as follows.

1. Posting norms with posting tenure of Tax Assistant:

In this regard, attention may be drawn to Office Order No. 08/2016 dtd 22.04.2016 regarding "Rational Transfer Policy for Ministerial Staff(A.O/E.A.(DOS, STA)/T.A/LDC) under Kolkata Customs Zone 2016. In this context, it may be pertinent to mention that there is no separate posting norms for the cadre of Tax Assistant.

2. Places Tax Assistant can be posted under Commissioner of Customs, Kolkata:

In this regard, attention may be drawn to Point No 10 of the aforesaid Transfer Posting Policy, wherein it is mentioned that "Notwithstanding anything mentioned in the above policy, any Officer can be transferred from any section to any other on the written direction of the Chief Commissioner of Customs, Kolkata due to Administrative Exigencied."

If you are aggrieved with the above information, you may prefer an appeal against the same to the Shri P.C.Nayak, Addl. Commissioner of Customs, 1st . Appellate Authority(A&A), Office of the PRINCIPAL COMMISSIONER OF CUSTOMS (AIRPORT & A.C.C.), Custom House, 15/1, Strand Road, Kolkata-700 001 within 30(thirty) days from the date of receipt of this letter.
